The Participant voluntarily agrees to display vehicle(s) and/or equipment owned by the Participant identified hereinbelow at the Town of Church Hill’s 150th Birthday Celebration (“Event”) Touch-A-Truck exhibit (the “Exhibit”), located at Church Hill Park, 1130 Sudlersville Road, Church Hill, MD on Saturday, June 6, 2026 (with a rain date of Saturday, June 13, 2026) from 5 – 9 p.m. I acknowledge and agree that the Town undertakes no responsibility for inspecting or maintaining the vehicle(s) and/or equipment displayed at the Exhibit. Participant shall provide an individual at the Exhibit to supervise and control the public’s interaction with the vehicle(s) and/or equipment.

I acknowledge and agree that I place the vehicle(s) and/or equipment or permit the vehicle(s) and/or equipment to be placed at Church Hill Park at my sole risk and that the Town, and its servants, agents, employees and officials, shall not be liable to me for any claims, demands, injuries, damages, actions, or causes of action whatsoever, arising out of or in connection with the use of or presence on Church Hill Park property of the vehicle(s) and/or equipment.

Participant may begin setting up for the Exhibit at 3 p.m. on the date of the Event and must be completely set up for the Exhibit no later than 4:30 p.m. All vehicles must be removed from Church Hill Park no later than 10 p.m. on the date of the Event. Participant understands that the Event is a public, family-oriented event where adults and children can view, touch or occupy vehicles that are part of the Exhibit. It is Participant’s responsibility to ensure that Participant’s vehicle(s) are secure and remain off at all times during the Exhibit. Participant retains full discretion over public interaction with Participant’s vehicle(s). Participant acknowledges the inherent risks associated with public vehicle displays such as the Exhibit and voluntarily assumes all risks related to his/her/its participation in the Exhibit. Participant certifies that displayed vehicles are properly insured in accordance with applicable law. Participant agrees to release, defend, indemnify and hold harmless The Commissioners of the Town of Church Hill, Maryland and the County Commissioners of Queen Anne’s County from any claims, damage, losses or liabilities arising from Participant’s participation in the Exhibit.
